BG while we are on very different sides of this case, I respect the questions you are asking and the tone in which you are asking them. (take note CSI) I will try to answer them the best I can.

Firstly, Megan was told at the scene that David was dead before the fire. The Fire Chief on scene told her that. According to testimony, he did not specify HOW David was killed. Megan also testified that when Scott told her that the police at his house told him that 'they had just come from another house fire where a guy was shot in the head'; Scott then went on to tell Megan that someone had shot at him and tried to set his (their marital home) house on fire too. Megan was then focusing on the fact that some masked man had just tried to kill Scott and burn his house down. Megan already knew from the fire chief that David had been murdered. I know when I hear the word 'murdered' I usually think 'shot'. So I don't believe that hearing that David had been shot was a huge shock to her. Hearing that Scott had been attacked AGAIN was a HUGE shock and that was the part of the conversation she was paying attention too. By all accounts she was completely hysterical when all of these conversations were happening and multiple people testified to her taking Valium.

I know it is troubling that Megan did not initially remember being told the night of the fire about David being shot. I also know that memory is a tricky thing, even when there are not traumatic events happening. Memory can be vague one day and crystal clear the next. Take a mundane item like a nice pen or sunglasses. When you first misplace one of these items it is hard to remember where you last left them. Then all of a sudden it will pop back into mind. Megan had to really think about who told her what, when once her life became a bit calmer. She initially assumed, like the defense team, that an official on the scene told her. But then she remembered who really told her. She says her memory of events is now crystal clear. Personally, I believe her. I believe her because she has no motivation to lie. She has a ton of motivation to lie
