Fall 2004

October, Friday

- -Went to 1150 Club. Met D.S. and friends. Scott Davis there.
- -Went to friend's home for party, met D.S. there and spoke to Scott Davis
- -Took D.S. home, did cocaine on badge and ecstasy. Gayle provided.

Saturday

- Met D.S. and Scott Davis after UGA football game at party. Gayle invited. Gayle's friends knew Scott Davis
- More cocaine. Scott Davis does no drugs.
- -Makes plans to go to Palo Alto for Halloween to see D.S.

California

- Halloween weekend -Fri: meet D.S. and friends no Scott Davis more cocaine with D.S., W, Kelly, others
 - -Sat: Halloween Party at Cow Palace, S. F. D.S.
 - -Gayle insists go to party Exotic Erotic Ball sexy costume
 - -Meet Scott Davis and friends and tag along in limo to party
 - -D.S. and Gayle no tickets but eventually get in.
 - -Get separated from D.S., stay with Scott Davis no mention that She is D.A.
 - -Beers, drinks, cocaine Scott Davis does no drugs
 - -Gayle didn't feel well, gets separated
 - -Bathroom laying on floor. Asked woman for help.
 - -D.S. angry with Gayle for leaving him.
 - -1:00 a.m. Gayle calls Rand Csehy (another A.D.A.)
 - -Wants to go home, leaves DA and Scott Davis goes into parking
 - -Meets 3 black men in SUV does more cocaine with them
 - -D.S. and Scott Davis looking for Gayle
 - -Scott Davis finds Gayle in car doing cocaine.
 - -Men offer ride to S.F.
 - -Mad at D.S. "Thank God for Scott Davis) Relieved that he got me into safe situation"
 - -Go to S.F. to party Scott Davis left.
 - -More drugs. Fighting with D.S.
 - -Don't remember what happened.

- -Called Rand Csehy (ADA) but don't remember what said.
- -Next back to her hotel room with D.S. Calls him an ass
- -Never saw Scott Davis do drugs. Know nothing bad about Scott Davis. In fact, saved me from dangerous situation
- -Flew home. Cut things off with D.S.

March 11, 2005 April

- -Courtroom shooting
- -Go to Palo Alto, CA for wiretap with Rand Csehy (ADA leading the wiretap)
- -Now dating Rand Csehy (ADA)
- -Wire starts on April 18th.

Wed. -Chambers holds "renegade" press conference with false Information. <u>However, DA Sheila Ross knew exactly what Chambers was doing.</u>

-Wiretap about Gayle became evident and Rand said he would have to remove himself from case.

Fri. –Chambers goes home Sun -Go back to Atlanta

- -Gayle goes straight to Paul Howard.
- -Howard didn't ask about drugs.
- -Howard say he will have a U.S. Attorney interview Gayle Abramson
- Gayle, upset, crying Howard was not sympathetic.
- Gayle left D.A.'s office May 3rd, 2005
