On March 7, 1997, Moran was interviewed by D. Miller and M. Kadish in the offices of attorney Bruce Morris, after being advised of the identity of the interviewers and the purpose of

the interview. Moran had previously been telephonically interviewed by D. Miller and this was a

follow-up, in-person interview to that telephone call.

Moran stated she had known the victim, David Coffin, for approximately five years and had

"dated him" off and on over that period of time. Moran indicated that she was aware of Coffin's

relationship with Megan Davis since the Friday before Thanksgiving 1996. Moran indicated she

had last seen Coffin on Sunday, December 1, 1996 and, at that time, Coffin told her he was not

going to see Megan any more.

Moran indicated that the day after the fire at the Coffin residence, she went to the Coffin

residence and saw Coffin's step-brother, John Bissell. Moran recalled that it was approximately

3:30 in the afternoon. Moran indicated she introduced herself to police personnel on the scene

and indicated to them that she "may know something about Coffin's death." According to Moran,

police officers "didn't even ask her name."

It was Moran's understanding that Bissell had gone back to the Coffin residence on the

Thursday after the fire and Bissell told Moran that Coffin's filing cabinets were missing. Bissell

also told Moran that Craig Foster was found "wandering around inside the Coffin house."

According to Moran, Bissell eluded that Foster may have taken Coffin's filing cabinets.

Moran indicated that Coffin owned a 30 foot cigar boat that was in dry storage at Lake

Lanier in a storage facility next to Holiday Marina.

Moran indicated that Coffin and his family were not close and it was Coffin's family which caused him to move away from Connecticut and to Atlanta to get away from them.

Moran indicated that there was a individual she felt could be responsible for the burglary at Coffin's residence and, ultimately, his death. Moran explained that a Porsche mechanic named Kenneth C. Criswell, who formerly worked at Foreign Auto Repair on Fairground Road, Marietta, had worked on both hers and Coffin's Porches. Moran described Criswell as being a white male, 47 to 48 years old, with red hair. Moran indicated that Criswell had "stolen parts" off of her vehicle and that both she and Coffin "had problems with him." Moran indicated that she spoke to Coffin on Monday, December 9, and during that conversation, they discussed the possibility of Criswell being involved in the burglary at Coffin's residence on Saturday. According to Moran, Coffin indicated that he was "going to try to run Criswell down on Monday, December 9." Moran stated that her contact at Foreign Auto Repair was Eric who can be reached at 770-422-4043. According to Moran, Criswell "packed up overnight and left" approximately two to three months before the Coffin homicide. Moran indicated that she had heard that Criswell had formerly worked at Peters' Coachworks on Old Canton Road, Marietta and at one point was living at the Suburban Lodge on Cobb Parkway in Marietta.

Moran indicated that she was aware that Coffin had experienced previous burglaries prior to the December 7 burglary. Moran stated that on December 1, the last time she was at the Coffin residence, she had noticed that an antique desk, some lamps and pictures were gone. Moran questioned Coffin about the missing articles and she stated he replied, "he'd been moving things around." Moran indicated that Coffin appeared "edgy" on this date. Moran recalled that

Craig Foster had told her that Coffin had had two to three burglaries prior to the December 7 burglary.

Moran had a telephone conversation with Coffin on Friday, December 6, 1997 between 2:30 PM and 4:00 PM. Moran stated she called Coffin to ask him to pick her up from an auto repair shop; however, he sounded unusual on the telephone and told Moran, "he didn't want to leave home."

During one of the Monday, December 9 conversations Moran had with Coffin, he indicated that he was very busy and had contacted Moran about an address for Criswell. Prior to hanging up, Coffin told Moran that he would "call her at 8:00 PM." At 8:00 PM, Moran's phone rang and the caller hung up before she could answer it. On her Caller I.D. box was the imprint "out of area," which Moran believes was Coffin calling her from his car phone.

Moran indicated that she was aware of three rifles, a hand gun, and Coffin's Porsche being stolen in the December 7 burglary. Moran indicated Coffin told her that whoever committed the burglary must have "spent hours because they went through everything." Moran stated Coffin told her, "they took everything," but was not specific about anything other than the rifles, hand gun, and car. Moran stated that she was aware that Coffin owned a hand gun because Chuck Teasley of Cumming, Georgia went with Coffin to buy the hand gun. Moran did not know where Coffin purchased this hand gun.

Moran's understanding of Megan Davis' knowledge concerning the death of David Coffin was that Megan had called Craig Foster and stated she was "worried about David." This call allegedly took place on Tuesday, December 10, 1996. According to Moran, she was told Megan, a friend, and Craig Foster went to the Coffin residence, noticed the fire, and went to a neighbor

whom Moran described as the Limberger house to call police. According to Moran, police went to Limberger's residence to speak to Megan, where she told police that Scott Davis had recently bought a gun. According to Moran, on December 11 when she approached police and told them that she may have information regarding Coffin's death, the police department told her, "we don't need it. We already know who did it." Moran said she was accompanied by Sue Seiler when this conversation with police took place.

On February 25, 1997, Dennis Miller placed a telephone call to 404-233-6218, the home telephone number for Linda Moran. This call was placed at approximately 2:00 PM. The following is a verbatim transcript of that telephone conversation.

DM:

Hi. Linda Moran, please.

LM:

This is she.

DM:

Ms. Moran, this is Dennis Miller.

LM:

Hi, Dennis. How are you?

DM:

Good. I called and left a message for you yesterday and you returned my call and

missed me, of course.

LM:

Yes, and let me get off my other line, okay.

DM:

Okay, great.

LM:

Seems as though I lost that person.

DM:

Uh, oh. Sorry about that. Sorry about that. Ms. Moran, I'm a private

investigator...

LM:

Oh, wonderful. What did I do? Nothing.

DM:

And I work for a company called Huhn & Associates.

LM:

I was wondering what that was.

DM:

Are you perplexed as to why I'm calling you?

LM:

Yeah, I'm kind of...any time I get a call and I don't know who it is, I'm always

perplexed.

DM:

Okay. I'm working for a law firm down in Tower Place there in Buckhead. The

attorney that I'm working with is Bruce Morris and Mr. Morris is representing Scott

Davis.

LM: Okay...

DM: And Mr. Davis has been charged with murder in connection with the case involving

David Coffin...

LM: Right, yes, I'm familiar.

DM: Okay. We obtained through subpoena from Southern Bell Mr. Coffin's telephone

records and we noted a variety of phone calls either to or from you or your

number.

LM: Oh, yes. We, we were very good friends for years.

DM: Close friends? Okay.

LM: As a matter of fact, Scott Davis was a rental tenant of mine years ago, so I don't...I

don't know if that makes any difference, if I should be speaking to you or get my

own attorney, but I'm pretty sure it's the same Scott Davis.

DM: As far as you getting an attorney, the only reason that I'm calling you is because

of the telephone calls that took place on December 9, which is the day that the

medical examiner believes that Mr. Coffin was killed.

LM: Monday?

DM: Yes, uh huh. And I was calling to just ask you about your conversations with him

and without revealing anything of a personal nature, if there was anything about him or anything that he said during those conversations which was unusual to you or sounded strange, or if there was anything about those conversations that just

arouses your suspicions in any way.

LM: Well, I had seen him a few times before that and I knew similar, what was going on and we had talked about, you know, since I was kind of seeing him at the same

time and we had recently started seeing each other again. He was trying to break away from this girl. He really didn't want me to know a whole lot. But, he said he was having some trouble with some guy and, you know, he'd been burglarized several times. But, I had talked to him that Monday morning and he was going to, he said he thought he knew who was doing all these things, but I thought I might have a lead on somebody else who might have done it and he agreed that was a possible lead and he was going to go check into it. But as far as I know, he did not do that. Of course, I never talked to him again. I called him and left him a message on his recording Monday afternoon and Monday night he was suppose to call me and I had a call, I believe it was from him, but it must have been from

his car phone about 8:00.

DM: About 8:00 PM, Monday night, you say? And, why do you think it was from him

in his car phone?

LM:

Because he said he'd call me.

DM:

Okay. So, he said earlier in the day that he would call you that evening.

LM:

He said, I'll call you tonight. I've got some errands to run. I'll call you on the way home and maybe we'll get together and the phone rang and I just didn't get to it in time and it was from a car and David always just hangs up. I'm pretty sure it was him. I mean I've always had mental telepathy and that's I said, he was always afraid of me, I think. And I would say, cause I was over there before this happened a couple of times and would say, David, what's going on? And he was kind of paranoid, but he didn't want to say anything.

DM:

What do you mean, he was, a couple of, how far before that Monday or how long before that Monday?

LM:

Well, the Sunday week before we had gone out and I had gone over to his house later and, you know, I discussed things were missing. Because we were engaged at one time and his father talked him out of it because of the money, I guess. But anyway, we, he said, well, I've been rearranging things, but he was walking around very funny, like looking around and checking things and I didn't know why, but I never asked him and then Friday afternoon I called him and he was going to pick me up while I was dropping my car off to get fixed and he was really a nervous wreck about something, which he never was. And, he really didn't want to leave the house to come meet me, but he said I will if it's an emergency and I found another ride and then he called me, the next time I heard from him was Sunday morning or early afternoon when he called and said he got robbed again.

DM:

You mentioned earlier that you had a suggestion of someone that you thought might be giving him a hard time.

LM:

Well, it was we both had Porches and we had a Porche mechanic that I knew. He took advantage of me. I'm in the middle of trying to find him. But, I knew he always knew David had a lot of money and this guy got into some trouble and disappeared and owed a lot of people money. So, I thought, maybe he went after David. But, in doing my investigative work, it was not him.

DM:

It was not him. What did you do? What kind of investigation.....

LM:

Well, I made some phone calls and found out that the guy was, you know, no where around at that particular time. That he was unavailable with his girlfriend somewhere.

DM:

I got cha'.

LM:

But, really, everybody, since you're defending Scott Davis, everybody says he did it. Even his estranged wife, but...

Oh, you know her as well?

LM:

Well, see he was engaged to her when he rented a house from me. This is the same Scott Davis that lived on Moores Hill Road at one time?

DM:

Yes, I believe so.

LM:

Okay. He was the first tenant with Scott Aldridge and another guy and I rented them a house and it was really ironic because David went over there with me a couple of times. But, he moved out and they all moved out because Scott Davis was going to marry Megan. And I had met her, but as the landlord.

DM:

Right, right.

LM:

And, it's real strange how things work out. But, I heard he was always a little strange.

DM:

Really.

LM:

Yeah. I've always heard that, even thought people that lived there that he was kind of introverted and, you know, he was not around very much.

DM:

Right. Do you remember what time of the day on that Monday was the last time you had talked to David?

LM:

I talked to him about, it was between 10:00 in the morning and about noon time. But, I left him a message. This is what was really weird. I was leaving a car dealership and Monday afternoon I was going to go over there and I left him a message because I was sitting in a waiting room and I read his horoscope and I left him a message that I read that good things were going to happen to him and everything was going to be okay. And, I'm sure that was the last message he got. He wasn't at home and he came home and all this happened. But, what time was it, about 9:30 or something?

DM:

Well, the medical examiner, no, the fire actually took place on Tuesday the 10th.

LM:

Right, but he was killed on Monday.

DM:

Right, and the medical examiner has been very...it's not as easy as it sounds or as they say on TV as far as pinpointing a time of death. They can give you a range. The medical examiner's range of David's death was some time between midnight Sunday and midnight Tuesday. Well, we know that he was alive on Monday because people had telephone conversations with him.

LM:

Right.

From his telephone records, it looks as though the last outgoing telephone call where he made a call was at about 6:00 PM on Monday, the 9th, and then after that, there were no outgoing calls and none of the incoming calls were of significant length more than a minute. So, I'm assuming that the incoming calls were people calling in and leaving messages for him. Right. And that's why I was interested as to what time you actually last talked to him. I know, according to his phone records, you last talked to him from him calling you at 11:58 in the morning and you and he talked for about six minutes and prior to that, you had a 29 minute conversation....

LM:

Sunday.

DM:

Right.

LM:

So, you really don't, there are no records of him calling me later that evening.

DM:

No.

LM:

The one that came in was from his car phone. Can you judge on car phones?

DM:

We don't have his car phone records yet and we're still in the process of...it's a lot easier to get Southern Bell's or Bell South's records from home phones or actual hard lines, but when you're talking about a cellular service, the phone company will tell us what cellular service and then we have to go through the cellular service to get their records. It's just a lot more complicated and eventually we will have those records, but as of right now we don't.

LM:

Well, you know, I'm glad that, I have this feeling that it was probably to do with this because I was real surprised that nobody questioned me before because, you know, I knew that David had a lot on his mind and I knew he was really trying to get away from this girl, but she kept saying that he'd come by. He's possibly bothering me. But I know David was, he was kind of different himself. I often wondered why nobody ever contacted me before because I've been like best friends with him for years.

DM:

Really. Well, to be honest with you, the only place that your name has come up is through these telephone records and we just recently got those. You know, we've interviewed literally tens of people. I can't tell you, probably 100 to 110 interviews and your name has not come up, so otherwise we would have been contacting you a lot sooner.

LM:

Well, the reason, he and I were dating years ago and when we, just recently when all of this started coming up was when he started coming around again. I was always like his protection advise, you know, and I was in a totally different league than any of his other friends were much younger and David's wild group, I called it. You know, they're all nice people, but I just didn't socialize with them.

Right, I understand. You mentioned that Megan said that he's bothering her. Are we presuming that that's Scott or do you know for sure that that was Scott?

LM:

Well, no. It's coming from David's lips. They were...you know this girl, cause we'd gone out the Friday night pre...or that Sunday night that I was over there with another friend of mine and he was saying that he'd been seeing this girl and he was really trying to break it off and her boyfriend was a lunatic or he'd say her boyfriend was a lunatic and she won't let go and she keeps calling me and wanting me to come over there because, you know, he keeps bothering her.

DM:

So, he said her boyfriend was a lunatic, not her husband?

LM:

Well, no, he, David Coffin said that her boy, he didn't want to elaborate on if this girl was married cause he knew I'd give a bunch of static about it. But, if he had told me the names, I would have known exactly who they were.

DM:

Sure, Sure.

LM:

Well, what is happening with this case. I've often wondered who to call and it bothers me every day. I mean, David was like, everybody has always thought, everybody said you and David are going to end of getting married.

DM:

As of right now, the case is actually, it's not stalled or it's not being slowed down or anything, it's just in the court process that unfortunately in Fulton County courts they run, they tend to run a little bit slow because of the overload of cases. So, Mr. Davis is still in jail and as far as we can tell, the Atlanta Police Department feels they have the person responsible for Mr. Coffin's death in jail, so they're not really investigating it any further, to my knowledge. Part of my responsibility and why my firm has been brought into the case is that we're concerned that the truth about the case come out. Now whether or not Mr. Davis did it or not, I really have no opinion of that. It's just, you know, Mr. Davis has his side of the story. The police have, what they believe, is their side of the story and I'm suppose to make sure that it's right.

LM:

Right. Well, I do know that Craig Foster, I'm sure you've talked to him.

DM:

I have not talked to him yet, but he's on my list.

LM:

Okay, now he and David were like best friends, as far as I know. But, he was with her the night the fire started and evidently she had called him and suggested that she should have told David, but that she knew that Scott had a gun and was threatening to kill David. So, she knew to go over there for some reason the night the house was on fire. She was the first person on the scene, which is a little strange.

DM:

Yeah, for sure.

LM:

So, when I went over there, I heard it on the radio and thought, that can't be David, and drove over there and the fire department was there and it was the day after. But, nobody questioned me. Nobody asked what my name was. They said, we know who did it and we're not even sure this is David's body yet. And I thought, you don't even know my name. I might be able to help and they weren't interested. So, evidently, I guess, who knows. It's a sad story.

DM:

It is a sad story.

LM:

Makes you not want to go out on dates any more.

DM:

Sure. I have a couple of more questions which are a little bit more on a personal nature here and, you know, whether or not you want to answer them or if you can answer them...

LM:

I'd be glad to help you.

DM:

Okay. During the medical examiner's examination of David's body, it was discovered he had an extremely high alcohol level in his system. During any of the conversations with him that you had that day, did you get any indication that he had been drinking?

LM:

No, I didn't get any. But if it was late at night, he probably had.

DM:

Okay. There was also a detectible level of cocaine in his system.

LM:

Well, see, that's one thing Dave never discussed with me because he knew I hated cocaine. I always wondered if he did it.

DM:

Where there any friends of his that you feel, you know, you felt that if he was, you know you just said you obviously wondered, are there any of his friends that he socialized with that you, that gave you that feeling that they were probably using and you didn't like David being around.

LM:

Well, you know, I felt like an old hen. I don't, you know, I don't really know what made me think that I didn't know anything for sure and I say, I don't know any of his friends, but it's just like the trend to do. I've often wondered, people, my friends have said, does David do drugs? And I'd say, well, why do you say that cause I'd never noticed, but he never did any around me. I had a bad scene, an incident years ago and I just don't want anything to do with it.

DM:

Sure. I understand that. As far as the plans he had for that Monday night, do you know if he had any plans for that evening? I know that you and he were going to...

LM:

He said that, that Monday he had already know that I was going to go to this advertising party and at what time...Oh, no, that was Tuesday night, you're right.

But, Monday I was here and I was waiting on him to call and he, I think that's, he said around 8:00 and the call was at 8:00 when it said out of area on my phone and it might not have been him, but there are not too many people that call me anyway.

Right, well, hopefully.... DM:

Cause he said he'd call around 8:00...and I kind of got the feeling he was probably LM:

going to come by.

Right. DM:

And I got the feeling he didn't want to go home. After I was there that night, and LM:

this just might be intuition, that, you know, I really did notice that a lot of things

were like missing.

Like what? DM:

Well, he had beautiful antique furniture, some pictures, lamps and all kinds of LM:

things and looking around, all the little accessories were like missing and I said, what happened to your things. And he goes, oh, I've just been moving them around and I joked and I said, where you putting them, in the basement? And he

goes, no and he changes the subject real fast.

What about his stereo, was that missing? DM:

No, that all happened, he explained all that been gone. LM:

Over the weekend? DM:

That Saturday night when he got real... LM:

But you said there were accessories missing prior to that weekend.... DM:

Little things, like lamps and do dad things sitting around. LM:

And his explanation was he was just moving things? DM:

Yeah, he was just moving things around. LM:

Huh, okay. DM:

But there were, I noticed this and he supposedly, did the house get broken into LM:

two, three four times prior to this night?

No, I'm not aware of that. We obviously, we've gotten a copy of the police report from the one break-in that we knew about, but I'm not aware of any problems prior to that.

LM:

Well, I'm telling you now, it was broken into and I know that David liked to do detective work on his own. He's been like that ever since I've known him. I use to say, David, you're going to get in trouble, don't do this, but I know he was, he probably figured all along what was going on. He acted very peculiar about the whole thing and just like David's personality, he was going to save the world and go in and save her and, you know, everything's going to work out okay. But, knowing David, if this Scott Davis was threatening him, David was going to stand up and he wasn't going to involve the police and he was just going to show them up as a personal vendetta. Not that he was a bad guy, but he just wasn't going to let anybody do anything to him.

DM:

I understand and don't be defensive cause I understand. He was your friend and a terrible thing happened to him and, you know, I understand your feelings and so you don't have to apologize and you don't have to defend your opinion or anything. Do you know whether or not David owned any guns?

LM:

Oh, he had a lot of guns and they all got stolen. He had a collection of guys and he told me, that Sunday, he said you know, the weirdest thing about it is that they stole all my guns but the most valuable one that was the most meaningful gun to me. He said it wasn't the prettiest gun and, you know, I've seen his guns. I don't pay any attention to guns. But, it was a rifle and he said why they didn't take this one, I'm not sure, cause they were all right there together. I know that David is, as far as I know, did not own a hand gun because we talked about that several times because being a woman, I was kind of looking around for one. Because his house scared me. That Sunday night I spent the night with him before, it was very scary to me because anybody could get in the house if they wanted to. He didn't have an alarm system and when I used to date him, I used to go around and make sure all the doors were locked some of the time he didn't even lock them. So, right there that same spot where he found his body, or they found his body, is where he always was standing whenever he was in that house. It was so bizarre.

DM:

They mentioned that they thought that whoever broke into the house over the weekend probably got through the dog door.

LM:

Where there was a dog door...

DM:

How big was it, was it big enough for a person to get through?

LM:

Yeah, when he locked himself out, he got

DM:

Really, okay. You know, I've got one for my dog, which is a smaller dog, and I'm thinking there's no way anybody could get through that...

I didn't, I often accused him, let me see you get in that door, but I never saw him LM:

do it, but he said believe it, I did it. It's not the most pleasant sight to see, but it

was pretty big cause he had a big golden retriever.

Okay. So that is possible... DM:

Oh yes. That's very possible and, but, it seems like he'd put something over it, but LM:

anybody could get in that house....

Sure. Sure. DM:

And through any location. Knowing, when I talked to his step sister-in-law and she LM:

was so cold natured, she called and told me that he was dead, definitely David

and that he was been shot in the head and was dead, before the fire.

I'm sorry. DM:

He was dead before the fire. And I said, well that's good, he must have got a fast LM:

death. And she said, well they don't think that. And I thought, well, my God. And I know they found the shotgun next to his body and a pistol and I know that

Megan's husband had bought a gun, so I'm wondering if it was his?

No, it was not. DM:

Okay. LM:

He bought a shotgun some months before, but not the shotgun that was found in DM:

the house.

Oh, I know. I know who he was with when he went looking for a shotgun or I LM:

know somebody years ago that he went gun shopping with.

Scott or David? DM:

David. I don't know Scott. No, I only knew him as a tenant. So there's no other LM:

evidence that I would like to know about so I can let him rest in peace in my mind?

At this point, you know, none that I could, none that I would feel comfortable DM: sharing with you. What I wanted to do though was ask you if you would be willing

to meet with Mr. Morris in this case, who is the attorney, and then I'm sure could shed a lot more light. I'm a little bit, you know, I know most of the facts of the case as we've developed them, but as far as whether or not I can reveal them or

release them to anyone at this point, I don't feel comfortable doing that.

Well, that's fine. LM:

You know.... DM:

He's the man that was at the memorial service? LM:

Probably not. No, I would doubt that.... DM:

He was an attorney, I think, that was working on the trust. LM:

Yeah. That's possible. From my understanding, Mr. Coffin had a couple of DM: different attorneys, you know, business attorneys as well as the family attorney

that stepped in to start working on....

Yeah, that was the one. Well, I, he was with a friend of mine and they were about LM:

ready to take off on some business and all the information was there, but what the police told me when I was there that day that somebody had broken in and stolen

his personal files.

See, I'm not aware of that. DM:

His filing cabinet and I know he had all his personal paperwork in the filing cabinet. LM:

David wouldn't let anybody know. I never knew that David had that much money and if I had a known, things would have probably been different. But, he had all his files locked up and from what I understand, they were all stolen. They weren't

in the fire.

I've got a copy of the police report from the burglary and the only thing listed on DM:

the police report as missing are, let me find this, guns and his car, the Porche.

Yeah, but they tried to steal the (inaudible), but the VCR... LM:

Yeah, and it broke, yeah. DM:

And, they didn't take his stereo? LM:

Not that's listed on the police report. Now it's possible that, you know, that he DM:

overlooked it and called back and added it, you know, added an addendum to the

report, but...

But, he only filed that one police report. He didn't call in that anybody else had LM:

broken in earlier.

No, no. DM:

See, that's what I mean cause I knew that. And he didn't say anything? LM:

The only things that he reported as being stolen in the burglary was the big screen DM:

TV has been damaged, a 9MM pistol and a shot gun and the car, of course.

Okay, well. LM:

DM: Well, in any event, would you mind if the attorneys feel that it's necessary or if

they feel that, you know, they might gain some more insight into this, if they spoke

to you, would you mind if I'd give you a call back and schedule that.

LM: Oh, no. That would be fine. Believe me. I would, in any way I could help, I'd like

to help.

DM: Okay. Well, listen, I appreciate your telling...

LM: But, I don't know any of these other people very well, so I might not be able to

help.

DM: Okay. I appreciate your time this afternoon and I'll speak to Mr. Morris and I'll give

you call back and see if we can't schedule something.

LM: Well, thank you.

DM: Thank you. Bye bye.

Scott Davis Murder Case 04-10-2006 Interview with Linda Moran

On this date, I spoke by telephone to Linda Moran, who had called the Cold Case Office to provide information about the David Coffin Murder. Ms. Moran gave the following information:

- A. Moran met David Coffin approximately 2.5 years before his death, and dated him for several months when she believed their relationship to be exclusive of others;
- B. Moran said that she and Coffin went boating when they were dating, and that Coffin was sensitive about his father knowing that Coffin even owned a boat;
- C. Moran said that during this first courtship, Coffin asked her to marry him, but later decided not go through with the marriage due to the fact that Coffin wanted children, and she did not;
- D. Moran said that Coffin told her that he had been burglarized on previous occasions, but she did not know when these might have occurred;
- E. Moran said that she remained a friend of Coffin after Coffin began dating Megan, and that Moran and Coffin would speak "off and on" while Megan and Coffin were dating;
- F. Moran said that Coffin dated a lot of women during the time she knew him.
- G. Moran said that Coffin told her that Coffin had broken up with Megan several weeks before Coffin's death, and that Moran was dating Coffin in the weeks before his death;
- H. Moran said that she remembers talking to Coffin on the telephone on the Monday before Coffin's house caught fire. Moran called Coffin at approximately 1:00 PM to try to get him to pick her up from dropping off her car at the Porsche dealer. Moran said that the call was brief (less than one minute) and that Coffin said that he was very busy, and could not talk (she said he "sounded scared."
- Moran remembers being very angry at Coffin, because she said she had spent the previous weekend with him at his house, and now she felt like he was treating her very badly;
- J. Moran said, although she could not remember the weekend prior to that Monday, she was sure that she had spent it with Coffin, otherwise, she would not have been so upset with him refusing to pick her up at the mechanic's garage. She said she could have been wrong about which weekend it was that she spent with Coffin.

- K. Moran said that she and Coffin both had Porsches and used the same mechanic, who is now deceased.
- L. Moran said that on the Saturday night before the murder and fire, she spent the night with Coffin at his house, and spent "just about all day Sunday at his house with him."
- M. Moran said that on that Sunday, there were no police officers that came to the house, and that there was no burglary while she was there;
- N. Moran said that Coffin never told her that his Porsche had been stolen, and she said that she assumed that it was taken when Coffin was murdered;
- Moran said that she never saw Coffin ever did drugs, nor did she see anything in his house that would have led her to believe he was involved in drugs;
- P. Moran said that Coffin had "promised" her several items from the house such as paintings, but that his step-brother had refused her when she asked about them after his death;
- Q. Moran said that she remembered very clearly on the day of Coffin's house fire, she was driving on I-75 when she saw smoke and heard on the radio that "a millionaire's house was on fire." Moran said that she "just knew" that it was Coffin's house and drove directly to his home, through the yellow crime-scene tape, and up the driveway. Moran said that none of the officers or fire fighters would listen to her, and that she was not interviewed.
- R. Moran said that she saw the smoke at approximately 3:00 PM.
- S. Moran said that some friends of hers who knew that Coffin had asked her to marry him were Jean McIntyre, Sandra Tyson, and Heather Diskin.
- T. Moran said that she met with Bruce Morris shortly after these events because she thought that he was a prosecutor.
